It is envisaged that this will start with a focus on high net worth individuals and further developing the portfolio of major gifts, and then move on to other market segments including bequests, corporates, church and the general public.

You will also be responsible for building and coordinating collective global fundraising efforts across the Hagar global partnership to ensure better consistency of messaging, and increased quality of and response to Hagar's major donor, corporate, church, digital and regular giving and appeal efforts.

You will be comfortable with working with multiple stakeholders to build consensus, managing relationships from a distance and capable of thinking outside the box in a highly competitive fundraising environment.
